Chris Caron, American Safety - Gas Meter Bump Test vs Calibration—What You Need to Know - A bump test is a brief exposure of the monitor to gas in order to verify that the sensors respond and the instrument alarms function accordingly. The bump test does not check the accuracy of the instrument. This is where the calibration check comes in.
